AN ORDINANCE REVISING SECTION 24-6-13 AND 24-6-14 OF THE MOTOR VEHICLE CODE OF THE REVISED CODE OF ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Illinois, that:

The Motor Vehicle Code of the Revised Code of Ordinances of the City of Nokomis, Illinois, is hereby amended by adding thereto the following:

24-6-13 TRUCK-TRACTOR/SEMI-TRAILER COMBINATION All truck-tractor/ semi-trailer combinations are prohibited from parking on any streets or alleys within the city limits except for deliveries, at which time parking shall be only for so long as is necessary to accomplish said delivery.

- The City has established a parking area for truck-tractor/semi-trailer combinations. This is a courtesy extended to Nokomis residents only. All truck-tractor/semi-trailer combinations shall park on the designated parking lot at the rear of Nokomis City Hall in the designated parking places only. All combinations shall be backed up to, but no further than the existing posts or barrier.
- 2. All drivers shall register yearly, starting January 1, 2015, with the Nokomis Police Department (NPD), giving all information required by the NPD including but not limited to registration plate numbers, driver identification, owner, lessee and employer identification. If the semi-trailer contains hazardous materials in any amount the semi-trailer will be properly placarded using Department of Transportation Standards. The NPD will issue only one (1) truck-tractor/semi-trailer combination parking permit, per driver, per year. The permit must be permanently affixed to the driver door or sleeper birth at eye level. If a sticker is displayed with more than one year punched out, the permit will be considered invalid. The Chief of Police or designee reserves the right to approve or deny a permit to any driver or combination unit.
- 3. All drivers shall proceed in and out of the parking area as follows:

IN: Turn West off Cedar Street between the railroad tracks and the Montgomery County Re-cycling Shed, proceed to parking area:

OUT: proceed East between the railroad tracks and the Montgomery County Recycling Shed to Cedar Street. DO NOT USE THE EXIT ONTO ILLINOIS RTE. 16 ON THE SOUTH SIDE OF NOKOMIS CITY HALL.

- 4. Truck-tractor must remain connected to the semi-trailer at all times. The semi-trailer cannot be dollied down or disconnected from the truck-tractor. Bobtail tractors are not permitted to park on the lot.
- 5. Drivers are <u>NOT PERMITED</u> to dump garbage or perform maintenance (i.e., oil change, greasing, changing tires, fuel or air lines repairs, etc.) to the truck-tractor/semi-trailer combination on the parking lot.
- 6. Drivers must obtain permission from the NPD if the truck-tractor/semi-trailer combination will be parked longer than a 72 hour period.
- 7. In the event the truck-tractor/semi-trailer combination is not parked appropriately (parallel with the railroad tracks) within the parking area, or does not have the appropriate permit attached or is used for storage, the truck-tractor/semi-trailer or combination will be towed at the owner, lessee, lessor and/or drivers expense. The owner, lessee, lessor and/or driver shall be liable for all towing and storage costs as well as fines and court costs provided herein.
- 8. This ordinance is applicable to truck-tractor/semi-trailer combinations only. Parking is prohibited for any second division vehicle with a gross vehicle weight rating (GVWR) of 60,000 pounds or less and vehicles transporting mobile/modular homes.
- 9. The penalty for violation of any provision of this ordinance shall be a fine of not less than One Hundred Dollars (\$100.00) for the first offense. The second offense will result in a fine of Five Hundred Dollars (\$500.00). The third offense will result in the revocation of the permit. Each day of the violation shall constitute a separate offense. Said offense shall be a business offense, and shall be enforceable against the owner, lessee, lessor, and/or driver of said equipment.
- 10. The Chief of Police has the authority to revoke a parking permit at any time.

24-6-14 COMMERCIAL VEHICLES, TRAILERS AND RECREATIONAL VEHICLES

- All camping trailers, motor homes, construction or other trailers, commercial vehicles, dump trucks, box trucks, and recreation vehicles are banned from parking on any streets or alleys, including all rights of way, boulevards, and sidewalks within the City limits except for the temporary purpose of loading and unloading. Loading and/or unloading shall not exceed two (2) hours. Temporary parking permits for parking a construction trailer or commercial vehicle for temporary construction purposes in excess of two (2) hours may be granted by the Mayor or his/her designee. Applicants will apply to the City Clerk.
- 2. The penalty for violation of any provision of this ordinance shall be a fine of not less than **One Hundred Dollars (\$100.00)** for the first offense. The second offense will result in a fine of **Five Hundred Dollars (\$500.00)**. The third offense will result in the revocation of the permit. Each day of the violation shall constitute a separate offense. Said offense shall be a business offense, and shall be enforceable against the owner, lessee, lessor, and/or driver of said equipment.
