**Ordinance No. 2020**

**AN ORDINANCE AUTHORIZING THE SALE OF PERSONAL PROPERTY OWNED BY THE CITY OF NOKOMIS, ILLINOIS**

WHEREAS, in the opinion of at least a majority of the City Council of the City of Nokomis, Illinois, it is no longer necessary or useful to or for the best interest of the City of Nokomis, to retain ownership of the personal property hereinafter described; and

WHEREAS, it has been determined by the City Council of the City of Nokomis to sell said personal property via sealed bid; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS;

Section One. That pursuant to 65 ILCS 5/11-76-4 of the Illinois Municipal Code, the City Council of the City of Nokomis finds that the following described personal property now owned by the City of Nokomis, is no longer necessary or useful to the City of Nokomis and the best interests of the City will be served by its sale.

- 1950 CATERPILLAR NO. 12 MOTOR GRADER WITH DITCHING BLADE
- 2000 310SE JOHN DEERE BACKHOE WITH 2 FT BUCKET & DITCHING BLADE

Section Two. Pursuant to said 65 ILCS 5/11-76-4, the Mayor is hereby authorized and directed to sell the aforementioned personal property now owned by the City of Nokomis via sealed bid to the highest bidder on said property.

Section Three: That all Ordinances and Resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed.

Section Four: No bid which is less than the minimum price set forth in the list of property to be sold shall be accepted except as authorized by the City Council.

Section Five: That the City Clerk of the City of Nokomis be and is directed hereby to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

Section Six: Upon payment of full price, the Mayor is hereby authorized and directed to convey the aforesaid personal property to the successful bidder.

Section Seven: That this Ordinance shall be in full force and effect from and after its passage, by a simple majority vote of the City Council.
