#### AN ORDINANCE AMENDING SECTION 38-4-11 AND SECTION 38-4-12 OF THE REVISED CODE OF ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS REGARDING RATES AND CHARGES OF THE CITY WATER SYSTEM

WHEREAS, the City of Nokomis, Illinois (the "City") is an Illinois non-home rule municipal corporation pursuant to Article VII, § 8 of the 1970 Illinois Constitution, organized and operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1, et seq.; and

WHEREAS, the City of Nokomis operates a combined water and sewer system within the City (hereinafter, the "Nokomis Water System") and has previously established rates for the usage of the Nokomis Water System; and

WHEREAS, the Mayor and City Council of the City of Nokomis, Illinois have determined that the current water and sewer rates do not provide adequate funding for capital improvements for long-term sustainability of infrastructure and equipment and that the current rates charged cannot adequately provide for increases in costs for routine operations and maintenance of the Nokomis Water System; and

WHEREAS, to cover fixed costs associated with the Nokomis Water System and variable costs associated with operating and maintaining the water service and system;-to ensure sufficient funds are available to repay a low interest loan from the Illinois Environmental Protection Agency for Water System Improvements, the water rates for the customers of Nokomis shall be adjusted; and

WHEREAS, the Mayor and City Council of the City of Nokomis, Illinois have determined that it is in the best interest of the City of Nokomis and the customers of the Nokomis Water System to amend certain provisions of the City Code, to adjust the rates charged for waterworks and sewerage utility services, and to provide for a capital improvements surcharge.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the City Council of the City of Nokomis, Montgomery County, Illinois, as follows:

<u>SECTION 1:</u> The above recitals are incorporated herein and made a part hereof.

<u>SECTION 2:</u> Section 38-4-11 of the Revised Code of Ordinances of Nokomis, Illinois is hereby amended to read as follows:

**38-4-11** <u>**RATES ESTABLISHED**</u>. There shall be established the following rates and charges for the use of the waterworks system of the City, as follows:

(A) Base Rate. All users of the waterworks distribution system shall pay a minimum monthly bill of Eight Dollars Seventy-Five Cents (\$8.75) service charge per billing period for users inside the City limits and Eighteen Dollars Seventy-Five Cents (\$18.75) service charge per billing period for users outside the City limits (the "Base Rate"), per connection to the system. All users of the water distribution system will be increased incrementally in a three (3) phase rate increase to the Base Rate per connection, as follows:

- <u>Phase 1</u> Effective June 1, 2021 on bills having a due date of August 15, 2021: Ten Dollars Seventy-Five Cents (\$10.75) for users inside the City limits and Twenty Dollars Seventy-Five Cents (\$20.75) for users outside the City limits.
- <u>Phase 2</u> Effective May 1, 2022 on bills having a due date of June 15, 2022: Thirteen Dollars Seventy-Five Cents (\$13.75) for users inside the City limits and Twenty-Three Dollars Seventy-Five Cents (\$23.75) for users outside the City limits.
- <u>Phase 3</u> Effective September 1, 2022 on bills having a due date of November 15, 2022: Seventeen Dollars (\$17.00) for users inside the City limits and Twenty-Seven Dollars (\$27.00) for users outside the City limits.

(B) Variable Use Rate. The following rates are established, in addition to the Base Rate, based upon the amount of water consumed:

(1) <u>Water Rates Inside City Limits</u>. \$7.05 for each 1,000 gallons per month

> Effective June 1, 2021 on bills having a due date of August 15, 2021: \$7.19 for each 1,000 gallons per month

> Effective May 1, 2022 on bills having a due date of July 15, 2022: \$7.33 for each 1,000 gallons per month

- Effective September 1, 2022 on bills having a due date of November 15, 2022: \$7.48 for each 1,000 gallons per month
- (2) <u>Water Rates Outside City Limits</u>. \$10.27 for each 1,000 gallons per month
  - Effective June 1, 2021 on bills having a due date of August 15, 2021: \$10.48 for each 1,000 gallons per month
  - Effective May 1, 2022 on bills having a due date of July 15, 2022: \$10.68 for each 1,000 gallons per month
  - Effective September 1, 2022 on bills having a due date of November 15, 2022: \$10.90 for each 1,000 gallons per month

(3) <u>Annual Adjustment</u>. Beginning May 1, 2023, and each year thereafter, the Variable Use Rate applied to water rates per 1,000 gallons for customers both inside and outside city limits shall be automatically adjusted upwards by applying to the previous rates an increase equaling the greater of either (i) **two percent (2%)** or (ii) the rate of inflation, calculated based on in the Consumer Price Index for Urban Wage Earners and Clerical Workers: Midwest Urban Region, All Items Index, as published by the Bureau of Labor Statistics of the United States Department of Labor ("CPI") for the 365-day period ending on the most recent January 1<sup>st</sup>.

#### (C) Capital Improvements Surcharge.

(1) <u>Surcharge Established</u>. There shall be and there is hereby established a capital improvements surcharge which shall be assessed on all users of the waterworks system and added to each water bill when rendered.

(2) <u>Rate of Surcharge Imposed</u>. Each user of the waterworks system shall be assessed the sum of **Six Dollars (\$6.00)** for each month of service provided by the waterworks system. Said surcharge shall be in addition to any and all other charges imposed for waterworks service. Said surcharge shall not apply to "Bulk Water Sales".

(3) <u>User Defined</u>. For the purposes of this section, "user" shall be defined as any residence, each unit of a multiunit commercial or residential building, and each user within another entity using the City of Nokomis water treatment or distribution system.

(4) <u>Effective Date of Surcharge</u>. The capital improvements surcharge shall be effective, and shall be included, for all bills rendered on or after **June 1, 2021** and having a due date of **August 15, 2021**.

(5) <u>Itemization of Surcharge</u>. The capital improvements surcharge shall be included on all bills for waterworks service rendered and shall be separately itemized on each such billing.

(6) <u>Creation of Account</u>. In addition to any and all accounts maintained by the City Treasurer for the combined waterworks and sewerage system, there is hereby established a "capital water improvements surcharge account" on the books and records of the City. All proceeds of the capital improvements surcharge collected by the City Treasurer shall be credited to said account.

(7) <u>Partial Payments of Bills</u>. In the event that a bill including the capital improvements surcharge is paid in part by a user, the City Treasurer shall first credit the funds received to the "capital improvements surcharge account" then credit the remainder to the combined waterworks and sewerage system.

(8)Use of Surcharge Funds. Funds credited to the "capital improvements surcharge account" shall be used only for the construction, improvements, extension, and rehabilitation of the combined waterworks and sewerage system. In connection therewith, the City may pay with funds credited to the account the principal of and interest on any bonds or other evidence of indebtedness the proceeds of which are to be used for any or all of such purposes. The City Council may authorize the use of funds credited to the account for engineering and planning services necessary to determine the design, cost, or need of construction, improvements, extension, and rehabilitation of the combined waterworks and sewerage system. The City Council may authorize the use of funds credited to the account for payment of the cost of repairs to the combined waterworks and sewerage system when it determines that such repairs are necessary to maintain the proper functioning of the combined waterworks and sewerage system or any component thereof.

(D) Bulk Water Sales.

(1) <u>WATER RATES BY TANK LOADS</u>. \$0.75 per 100 gallons

(2) <u>VILLAGE OF COALTON</u>. In the absence of a written intergovernmental agreement approved by and between the Village of Coalton (the "Village") and the City, the following rates are established:

\$5.66 for each 1,000 gallons per month

Effective June 1, 2021: \$7.00 for each 1,000 gallons per month

Effective May 1, 2022: \$8.00 for each 1,000 gallons per month

Effective September 1, 2022: \$9.00 for each 1,000 gallons per month

Beginning May 1, 2023, and each year thereafter, the water rate per 1,000 gallons to the Village shall be automatically adjusted upwards by applying to the previous rate an increase equaling the greater of either (i) **two percent (2%)** or (ii) the rate of inflation, calculated based on in the Consumer Price Index for Urban Wage Earners and Clerical Workers: Midwest Urban Region, All Items Index, as published by the Bureau of Labor Statistics of the United States Department of Labor ("CPI") for the 365-day period ending on the most recent January 1<sup>st</sup>.

<u>SECTION 3:</u> Section 38-4-12 of the Revised Code of Ordinances of Nokomis, Illinois is hereby amended to read as follows:

38-4-12 <u>**REQUESTED SHUT-OFF.</u>** If water service is shut off at a user's request, there shall be a **Twenty Dollar (\$20.00)** fee to restore water service within the City limits and a **Thirty Dollar (\$30.00)** fee to restore water service outside the City limits.</u>

<u>SECTION 4:</u> A copy of this Ordinance, properly certified by the City Clerk, shall be filed in the office of the Recorder of Deeds of Montgomery County, Illinois and shall be deemed notice to all owners of real estate of their liability for service supplied to any user of the service of the combined waterworks and sewerage system of the City of Nokomis, Illinois on their properties.

<u>SECTION 5:</u> All ordinances, resolutions, motions, or parts thereof in conflict or inconsistent with the provisions of this Ordinance are hereby superseded to the extent that they may conflict.

<u>SECTION 6:</u> If any section, clause, paragraph, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.

**SECTION 7:** This Ordinance shall be in full force and effect from and after its passage, approval, and publication as provided by law.

<u>SECTION 8:</u> The Mayor is authorized and directed to sign and the City Clerk is authorized and directed to attest to this Ordinance.

<u>SECTION 9:</u> The Clerk shall publish this Ordinance in pamphlet form and see to inclusion of this Ordinance in the next update of the Code of Ordinances.
