SCHEDULE "D"

FIRE LANE

In accordance with the provisions of Section 24-6-3 of this Chapter the following "fire lanes" are established:

I.

Beginning at the Northwest corner of Block Twenty-four (24) in the Original Town, now City of Nokomis, running thence Northwesterly parallel with the Northeasterly line of Block Twenty-three (23) in the Original Town, now City of Nokomis a distance of thirty feet (30'), running thence Northeasterly parallel with the Northwesterly boundary line of Block Twenty-four (24), Twenty-five (25) and Twenty-six (26) in the Original Town, now City of Nokomis, to the Southwesterly boundary line of Maple Street in the original town, now City of Nokomis, running thence Southwesterly line of Maple St. in the Original Town, now City of Nokomis, a distance of thirty feet (30'), running Southwesterly along the Northwesterly boundary lines of Blocks Twenty-six (26), Twenty-five (25) and Twenty-four (24) in the Original Town, now City of Nokomis being the place of beginning situated in the City of Nokomis, Montgomery County, Illinois, excepting present acceptable fireproof structures now located within this described tract of land and also excepting that part of above described land crossing Pine and Spruce Streets.
