Commissioner Arkebauer reported to the council that the lift station on Capps is ready to start. Commissioner Arkebauer also stated that Cameron from Benton and Associates let him know that KMAX will be requesting a 30-day extension. Commissioner Arkebauer stated that they are still working on million-gallon water meter replacements. Commissioner Arkebauer stated that well 13 is up and running. Discussion was held on well service companies and potentially for grants for meter replacements.

Mayor Goldsmith stated that he had spoken with Roger from Farnsworth and Telescan was in town and completed most of the line televising, and most line is plastic and looked good.

Commissioner O'Malley reported revenues in the amount of \$91,304.27
