

ORDINANCE NO. 851

ORDINANCE AMENDING ARTICLE VI OF CHAPTER 24,
MOTOR VEHICLE CODE OF THE REVISED CODE OF THE CITY OF NOKOMIS, IL

Article VI of Chapter 24, Motor Vehicle Code, of the Revised Code of Ordinances of the City of Nokomis, Illinois, is hereby amended by adding thereto Section 24-6-10 as follows:

Section 24-6-10 Two-Hour Parking: "Two hour parking" is hereby established on certain city streets in the City of Nokomis, Illinois. The specified streets are hereby listed in Schedule L in the back of this Chapter. The said "two hour parking" shall be in effect from the hours of 8:00 A.M. until 5:00 P.M..


Schedule L

State Street	Cedar to Maple
South Spruce	R. R. tracks to Central
South Maple (east side only)	State St. to Central

Also Schedule K of Section 24-3-4 is hereby amended to add the following streets:

<u>Through Street</u>	<u>Yield Street (Direction)</u>
Monroe	Cedar (both)
Monroe	Pine (both)


