ORDINANCE NO. 853ORDINANCE VACATING STREET


Be it ordained by the City Council of the City of Nokomis, Illinois, that:

Pursuant to Statute, in particularly, Illinois Compiled Statutes, 65 ILCS 5/11-91-1 et seq, that the following alley, of the City of Nokomis, Illinois, is hereby vacated and abandoned by the City of Nokomis, and the City has determined that the vacation of said portion of such alley is in the best interest of the City for reason that said public alley has not been maintained, reconstructed or used in recent years and it is desirable to relieve the public from further burden and responsibility of installing, constructing, or maintaining said portion of said street, as described below:

An alley located on that certain Block located in Latimer's Addition to the City of Nokomis, Montgomery County, Illinois, containing Lots 61 through 78 and being bordered by ~~Monroe~~ St. on the North, Logan St. on the West, Madison St. on the South and Spruce St. on the East.

The City of Nokomis, hereby reserves an easement and right-of-way unto itself as well as to any present or future public utility,^{es} for ingress and egress in above and across the above described premises, as well as the right to maintain, repair, install, construct, build and remove any existing or future facilities or fixtures used for the purpose of continuing public services.


