

ORDINANCE 857

ORDINANCE AMENDING SECTION 1-2-24
OF CHAPTER I, DIVISION II OF THE REVISED
CODE OF ORDINANCES

Be it ordained by the City Council of the City of Nokomis, Illinois, that:

Subparagraph B of Section 1-2-24, of Chapter I, Division II, of the Revised Code of Ordinances of the City of Nokomis, Illinois is hereby amended as follows:

(B) Compensation. The City Attorney shall be entitled to receive remuneration for his services. The services for which the City Attorney shall receive the remuneration mentioned herein shall include the following:


(1) The giving of advice on all legal questions affecting the City whenever requested to do so by any City official.

(2) The drafting of ordinances and resolutions relating to any subjects within the authority or power of the municipality.

(3) The drafting or supervising the phraseology of any contracts, leases, or other documents or instruments to which the City may be a party.


(C) Additional Services. The City Attorney shall receive remuneration for services in the prosecution or defense of any and all law suits or actions at law or in equity, including prosecutions of violations or ordinances to which the City may be a party or in which may be interested or which may be brought against, or by any officer of the City on behalf of the City, or in the capacity of such persons as an officer of the City; representation of the City or any officer of the City on behalf of the City in labor matters and in the Appellate Court or Supreme Court of the State of Illinois or in any of the Federal Courts; legal services performed relative to bond issues, construction work, obtainment of easements and other services similar thereto.
