# AN ORDINANCE AMENDING CHAPTER 38 ARTICLE V DIVISION IV OF THE UTILITIES CODE OF THE REVISED CODE OF ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Illinois, that:

Division IV of the Utilities Code of the Revised Code of Ordinances of the City of Nokomis, Illinois, is hereby amended to read as follows:

"38-5-20 **PERMIT REQUIRED.** No person shall uncover, make any connection with or open into, use, alter, or disturb any public sewer or appurtenance thereof without first obtaining a written permit from the Superintendent. Further, in all instances incident to the connection of or repair of the connection of a building sewer to the city's sewerage system, such connection shall be accomplished only by a plumber licensed by the State of Illinois. **(Ord. No. 768; 08-08-88)**"

## "38-5-22 INSPECTION FEES.

(C) The permit application shall be supplemented by any plans, specifications, or other information considered pertinent in the judgment of the City Council. An inspection fee of **One Hundred Fifty Dollars (\$150.00)** for a residential or commercial building sewer permit shall be paid to the City Council at the time the application is filed. The permit shall require no fee in the case of a repair permit. The industry, as a condition of permit authorization, must provide information describing its wastewater constituents, characteristics and type of activity. (Ord. No. 786; 04-26-92)"

## "38-5-24 COST OF INSTALLATION.

(A) All costs and expenses incident to the connection or repair of a building sewer with the City's sewerage system shall be borne by the owner. It shall be the duty of the owner to maintain their own sewer line from the main sewer to the building.

(B) As a condition precedent to qualifying for a permit, and before making any repairs or connection to the City's sewerage system, the plumber engaged for such work shall provide the City with satisfactory proof of liability insurance to indemnify and save harmless the said City from any and all claims for loss or damage sustained that may directly or indirectly be occasioned by the plumber's street openings and work performed on public property. The amount of such insurance shall be not less than **Two Hundred Fifty Thousand Dollars (\$250,000.00)** for death or personal injury to **one (1) person, Five Hundred Thousand Dollars (\$500,000.00)** for each occurrence and **One Hundred Thousand Dollars (\$100,000.00)** for property damage.

(C) The liability insurance required under this Section may be "blanket coverage" for the entire period covering all proposed hookups. Additionally, the fact of liability insurance under this Section shall be a matter of public record, and any person making inquiry thereinto shall not be compelled to file for such information under Freedom-of-Information Act formalities. (Ord. No. 768; 08-08-88)"

#### Section 38-5-24 (D) is hereby repealed in its entirety.

"38-5-29 **EXCAVATION REQUIREMENTS.** All excavations required for the installation or repair of the building sewer shall be open trench work unless otherwise approved by the Superintendent. All construction shall be in accordance with the <u>Standard Specifications for</u> <u>Water and Sewer Main Construction in Illinois</u>, except that no backfill shall be placed until the work has been inspected. All excavations for building sewer installation or repair shall be adequately guarded with barricades and lights so as to protect from hazard. The City will provide the barricades, lights and fencing, but it shall be the responsibility of the owner and plumber to install and maintain such safety items on each project. Streets, sidewalks, parkways, and other public property disturbed in the course of the work shall be restored in a manner satisfactory to the Superintendent."

#### Section 38-5-30 is hereby repealed in its entirety.
