## AN ORDINANCE ADDING ARTICLE VIII TO CHAPTER 7 OF THE BUSINESS CODE OF THE REVISED CODE OF ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Illinois, that:

The Business Code of the Revised Code of Ordinances of the City of Nokomis, Illinois, is hereby amended by adding thereto the following:

- 7-8-1 <u>Definition</u> -"Yard Sale or Garage Sale" shall be defined as any sale held on the premises of a residence or place of business which sells personal property for sale to the public.
- 7-8-2 <u>Permit</u> Prior to conducting a Yard Sale or Garage Sale a permit must be obtained from the Nokomis City Clerk. There shall be no cost for obtaining the permit.
- 7-8-3 <u>Time Limit</u> Yard Sales and Garage Sales may only be conducted one time every 90 days at a given premises and may be conducted for a maximum of 3 days duration.
- 7-8-4 <u>Penalty</u> The penalty for violation of this ordinance shall be a fine of not less than Twenty-five Dollars (\$25.00) nor more than Five Hundred Dollars (\$500.00) for each violation thereof. Each day of the violation shall constitute a separate offense.
