## AN ORDINANCE AMENDING SECTION 38-4-11 and 38-4-33 OF THE REVISED CODE OF ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Illinois, that:

Section 38-4-11 and 38-4-33 of the Revised Code of Ordinances of the City of Nokomis are amended as follows:

38-4-11 <u>RATES ESTABLISHED</u> All users of the water distribution system shall pay a minimum monthly bill of Five Dollars Fifty Cents (\$5.50) service charge per billing period for users inside the City limits and Fifteen Dollars Fifty Cents (\$15.50) service charge for users outside the City limits per connection to the system. The purposes of this minimum bill is to recover the fixed overhead costs associated with operating and maintaining the water service, based upon the amount of water consumed monthly as shown by the water meters. (Ord. No. 834; 03-24-97)

Effective May 1, 2007 on bills having a due date of July 15, 2007:

- (A) <u>WATER RATES INSIDE CITY</u> \$4.55 for each 1,000 gallons per month
- (B) <u>WATER RATES OUTSIDE CITY</u> \$6.65 for each 1,000 gallons per month
- (C) WATER RATES BY TANK LOADS \$.50 per 100 gallons
- (D) <u>VILLAGE OF COALTON</u> \$4.39 per 1,000 gallons per month

38-4-33 <u>USER CHARGE SYSTEM</u> The following rates are established for the User Charge System:

(A) <u>User Rate</u> All users of the Wastewater Facilities of the City shall pay a minimum bill of **Three Dollars (\$3.00)** per billing period for users inside the City limits or **Eight Dollars** (**\$8.00**) per billing period for users outside the City limits for each connection to the system. The purpose of this minimum bill is to recover the fixed overhead costs associated with operating and maintaining the City's sewer system. (Ord. No. 834; 03-24-97)

- (B) <u>Inside City</u> \$3.35 per 1,000 gallons per month beginning May 1, 2007 (on bills having a due date of July 15, 2007)
- (C) <u>Outside City</u> \$5.00 per 1,000 gallons per month beginning May 1, 2007 (on bills having a due date of July 15, 2007)
- (D) Village of Coalton \$2.00 per 1,000 gallons per month beginning May 1, 2002
