Merle Street, between Singer Avenue and Illinois State Route 16 as shown on the plat of J.E. Haller's Subdivision situated in the City of Nokomis, Montgomery County, Illinois.

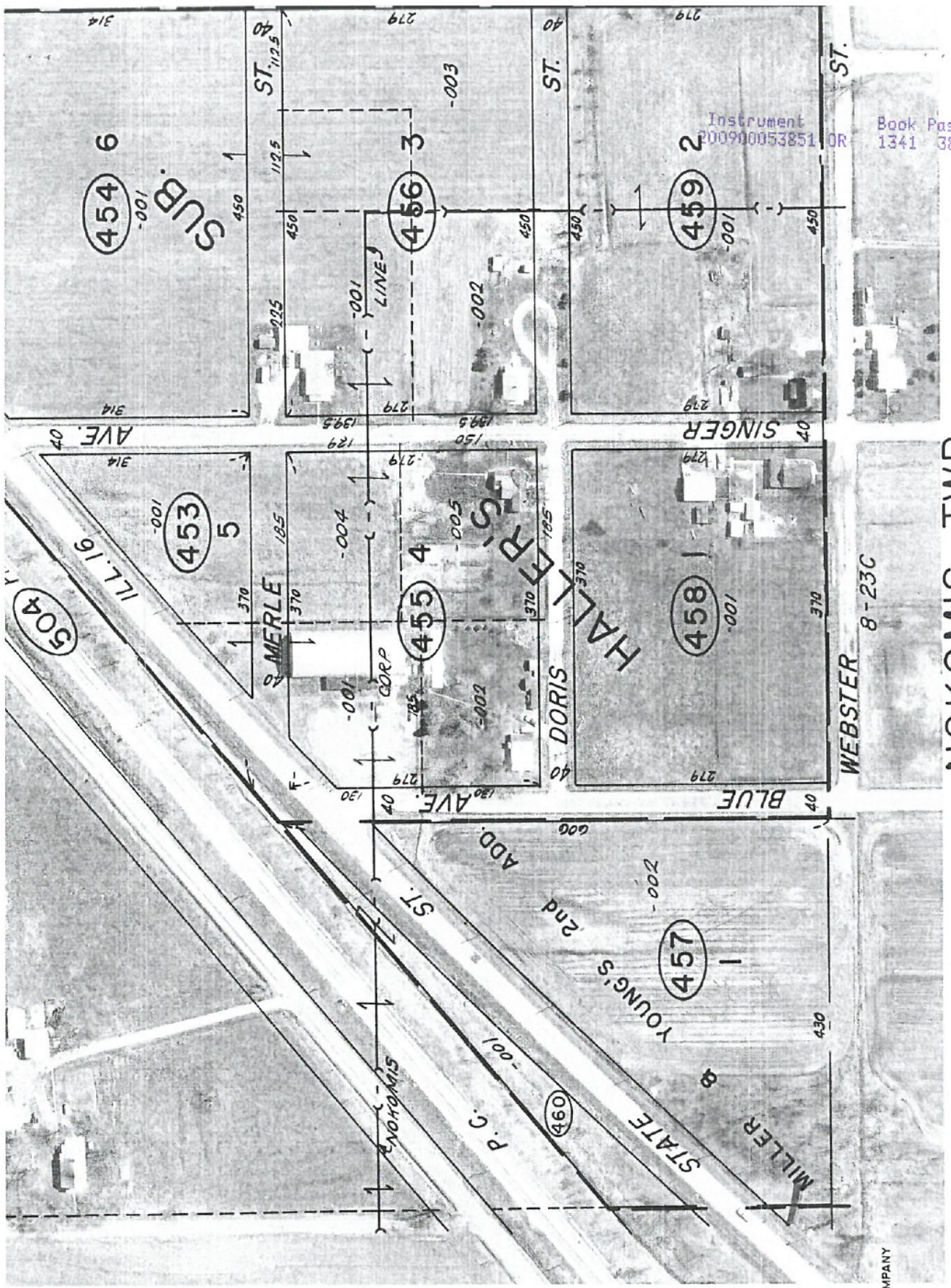



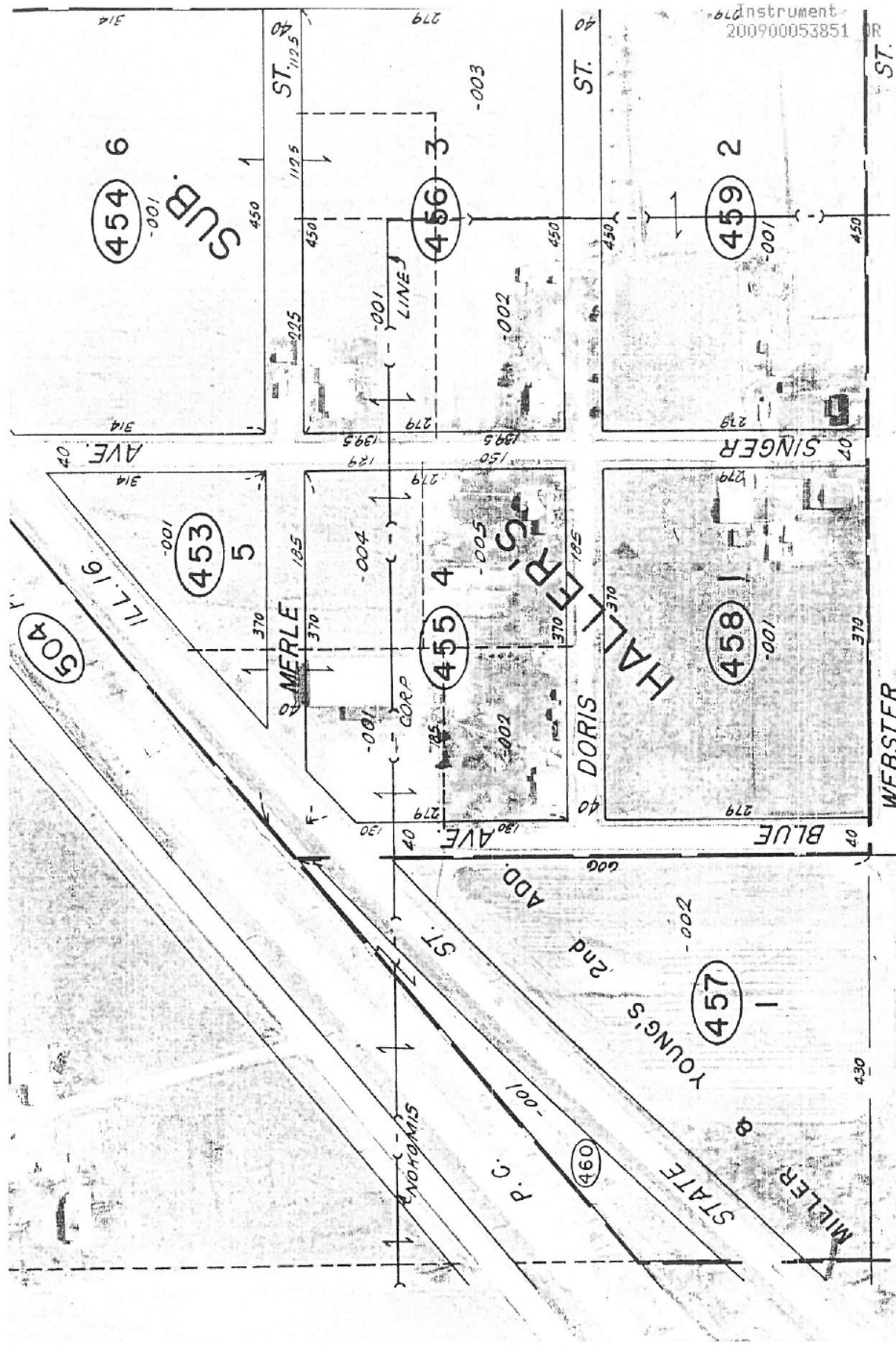
