

ORDINANCE NO. 957

ORDINANCE AMENDING CHAPTER 21 ARTICLE III
OF THE REVISED CODE OF ORDINANCES
OF THE CITY OF NOKOMIS, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Illinois that,

Chapter 21 Article III, Section 1 of the Revised Code of Ordinances of the City of Nokomis, Illinois, is hereby amended by deleting it in its entirety and replacing it with the following:

21-3-1 **HOURS.** It shall be unlawful to sell or offer for sale at retail any alcoholic liquor in the City between the hours of:

Sunday	2:00	A.M.	until	7:00	A.M.
Monday	12:00	A.M.	until	7:00	A.M.
Tuesday	12:00	A.M.	until	7:00	A.M.
Wednesday	12:00	A.M.	until	7:00	A.M.
Thursday	12:00	A.M.	until	7:00	A.M.
Friday	12:00	A.M.	until	7:00	A.M.
Saturday	2:00	A.M.	until	7:00	A.M.
Special: New Year's Day	2:00	A.M.	until	7:00	A.M.
Special: Thanksgiving	2:00	A.M.	until	7:00	A.M.

No patron shall remain or be permitted to remain or be admitted to any Class A licensed premises after the sale of alcoholic liquors is prohibited above, for the remainder of the closed hours described therein.

Consumption of liquor is prohibited, without exception, including employees or agents of the licensee, after the sale of alcoholic liquor is prohibited above, for the remainder of the closed hours described therein.

The doors of each licensed premises shall be locked and no person not in the employ of the licensee shall be admitted to or remain upon the premises during the times when patrons are prohibited from being on the licensed premises.

During the hours when the public is denied access to a licensed premises in accordance with the provisions above, investigators, inspectors, and police officers of the city shall have the right of entry for inspection of the licensed premises in the event that person(s) are present within the establishment to determine if any provisions of this chapter or any state laws pertaining to the consumption, sale or distribution of alcoholic liquors have been or are being violated.

Chapter 21 Article III of the Revised Code of Ordinances of the City of Nokomis, Illinois, is hereby amended by adding the following paragraph:

21-3-29 **OUTSIDE PROHIBITION.** No licensee or other person shall dispense alcoholic liquor or permit individuals to possess alcoholic liquor outside of the licensee's building or on property contiguous to such premises so licensed without special permit issued by the city.

Any holder of a retail liquor license or his agent or employee who violates any of the provisions of this Chapter shall, upon conviction, be fined according to the provisions of **Section 1-1-19** of this Code.

Passed by a majority vote of the members of the City Council and approved by the Mayor of the City of Nokomis, Illinois on this 25th day of January, 2010.


CERTIFICATION
