AN ORDINANCE AMENDING SECTION 1-2-4 OF THE REVISED CODE OF ORDINANCES OF NOKOMIS, ILLINOIS REGARDING NOTICE OF SPECIAL MEETINGS

WHEREAS, the City of Nokomis, Illinois (the "City") an Illinois non-home rule municipal corporation pursuant to Article VII, § 8 of the 1970 Illinois Constitution, organized and operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1, et seq.; and

WHEREAS, the corporate authorities find that it is in the City's best interests and appropriate to amend Section 1-2-4 to account for the realities of current technology and to provide for notice of special meetings by electronic means.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The above recitals are incorporated herein and made a part hereof.

SECTION 2: Section 1-2-4 is hereby amended to read as follows, with stricken provisions to be deleted and italicized provisions to be added:

- 1-2-4 SPECIAL MEETINGS. Special meetings of the City Council may be called by the Mayor or by any two (2) Commissioners by giving notice of no less than forty-eight (48) hours thereof. The call for a special meeting by any two (2) Commissioners shall be filed with the City Clerk in written form. The call for a special meeting shall specify the day, the hour, and the location of the special meeting and shall list the subjects to be considered.
- (A) Written or printed notice of the time and place of such meeting shall be delivered to the City Council members. The notice shall also specify the purpose of the special meeting and the business to be taken up at that time and place. The notice shall be posted at the City Hall, shall be provided to any local newspaper of general circulation and any local radio or television station that has filed an annual request for such notice, and shall otherwise be made and provided in accordance with any preemptive requirements of state law.
 - (B) Such notice shall be served upon the members of the City

Council by personal delivery by the Chief of Police or his designated representative; provided, however, that an announcement of a special meeting made during any regular meeting of the City Council shall be sufficient notice of such special meeting, in which case a courtesy copy of such notices shall be provided by email to the members of the City Council that have been specified for receipt of electronic correspondence, such as agendas

(C) Only such business as was listed in the notices of the special meeting may be transacted at the meeting.

SECTION 3: If any section, paragraph, or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Ordinance, which are hereby declared to be separable.

SECTION 4: All ordinances, resolutions, motions, or parts thereof in conflict with this Ordinance are hereby superseded.

SECTION 5: This Ordinance is effective upon its passage, approval, and publication as required by law.

SECTION 6: The Mayor is authorized and directed to sign and the City Clerk is authorized and directed to attest to this Ordinance.

SECTION 7: The City Clerk shall publish this Ordinance in pamphlet form and shall see to its inclusion in the next published update of the Code.
