AN ORDINANCE AMENDING SECTION 33-7-4 OF THE REVISED CODE OF ORDINANCES OF NOKOMIS, ILLINOIS PERTAINING TO SPECIFICATIONS FOR DRIVEWAYS

WHEREAS, the City of Nokomis, Illinois (the "City") an Illinois non-home rule municipal corporation pursuant to Article VII, § 8 of the 1970 Illinois Constitution, organized and operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1, et seq.; and

WHEREAS, pursuant to Section 1-2-1 of the Illinois Municipal Code, 65 ILCS 5/1-2-1, the Village "may pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities, with such fines or penalties as may be deemed proper"; and

WHEREAS, the City has determined that amendment of Section 33-7-4 of the Revised Code of Ordinances of Nokomis, Illinois, which pertains to specifications for driveways, should be amended.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Nokomis, Illinois.

SECTION 2: Section 33-7-4 of the Revised Code of Ordinances is hereby amended to read as follows:

- 33-7-4 <u>SPECIFICATIONS</u>. Driveways across sidewalks shall be constructed in compliance with the specifications as required by the Street Superintendent. In developing specifications for proposed construction, the Street Superintendent shall consider:
- (A) Current standards established by the Illinois Department of Transportation, including, but not limited to:

- (1) Number 227-424026-03 (Entrance Alley Pedestrian Crossings),
- (2) Standard Specifications for Road and Bridge Construction, and
- (3) Title 92, Chapter I, Part 550 of the Illinois Administrative Code (Policy on Permits for Access Driveways to State Highways); and
- (B) Any other standards or criteria deemed relevant to the proposed construction.

SECTION 3: All ordinances, resolutions, motions, or parts thereof in conflict with this Ordinance are hereby superseded to the extent of any conflict.

SECTION 4: If any section, clause, paragraph, or part of this Ordinance shall be found and determined to be invalid or unenforceable by a court of competent jurisdiction, the invalidity or unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Ordinance, which are hereby declared to be separable, and all valid parts that are severable from the invalid parts shall remain in full force and effect.

SECTION 5: This Ordinance shall take effect upon its passage, approval, and publication as required by law.

SECTION 6: The Mayor is authorized and directed to sign and the Clerk is authorized and directed to attest to this Ordinance.

SECTION 7: The City Clerk shall publish this Ordinance in pamphlet form and shall see to its inclusion in the next published update of the Code.
