**AN ORDINANCE AMENDING SCHEDULE “A” TO
CHAPTER 24 OF THE REVISED CODE OF ORDINANCES OF NOKOMIS, ILLINOIS**

WHEREAS, the City of Nokomis, Illinois (hereinafter, the “City”) is an Illinois non-home rule municipal corporation pursuant to Article VII, § 8 of the 1970 Illinois Constitution, organized and operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1, *et seq.*; and

WHEREAS, the Illinois Vehicle Code, 625 ILCS 5/11-208, grants the City authority to enact various traffic regulations within the City; and

WHEREAS, in pursuance of that authority, the City has heretofore adopted Chapter 24 of the Revised Code of Ordinances of Nokomis, Illinois (hereinafter, the “Code”) and Schedules thereto; and

WHEREAS, the corporate authorities of the City have determined that additional intersections within the City should be designated as stop intersections.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the Mayor and City Council of the City of Nokomis, Illinois.

SECTION 2: Schedule “A” to Chapter 24 of the Code, entitled “STOP INTERSECTIONS”, is hereby amended to add the following to “I. ONE AND TWO STOP STREETS”:

<u>THROUGH STREET</u>		<u>STOP STREET (DIRECTION)</u>
West South St.	at	South Walnut St. (South Bd.)

SECTION 3: Schedule “A” to Chapter 24 of the Code, entitled “STOP INTERSECTIONS”, is hereby amended to add the following to “III. FOUR-WAY STOP STREETS”:

<u>THROUGH STREET</u>		<u>STOP STREET (DIRECTION)</u>
West South St.	at	South Vine St.
West Union St.	at	South Pine St.

SECTION 4: The Street Department shall place appropriate signage to mark the foregoing intersections.

SECTION 5: This Ordinance is effective upon its passage, approval, and publication as required by law.

SECTION 6: The City Clerk shall publish this Ordinance in pamphlet form and shall see to its inclusion in the next published update of the Code.
