

ORDINANCE NO. 435

ANNUAL TAX LEVY ORDINANCE FOR THE FISCAL YEAR ENDING ON THE 30TH DAY OF APRIL, A. D. 1953.

WHEREAS the City Council of the City of Nokomis did, on June 2, 1952, pass the annual appropriation ordinance for said City for the fiscal year ending on the 30th day of April, A. D. 1953, in the aggregate sum of One Hundred Thirty-five Thousand Seven Hundred Dollars (\$135,700.00), which said ordinance was duly published in the Free Press Progress, the official newspaper of said city, on June 5, 1952, and is now in full force and effect and on file with the City Clerk, and

WHEREAS, the City Council having ascertained the total amount of appropriations legally made for all corporate purposes to be provided for by the tax levy of the current fiscal year;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS:

Section I

That there be and there is hereby levied upon all property subject to taxation, both real and personal, within the corporate limits of the City of Nokomis, Illinois, as the same is assessed and equalized for State and County purposes, for the fiscal year ending on the 30th day of April, A. D. 1953, the total sum of Forty-eight Thousand Five Hundred and Thirty-two Dollars (\$48,532.00) and the following specific purposes mentioned in said appropriation ordinance and in the respective sums as follows, the total amount of appropriations being detailed under the column headed "Amount Appropriated," and the total amount levied being detailed under the column headed "Amount Levied", as follows, to-wit:

17. For a Public Benefit Fund to be used for the payment of assessments for the public benefits against the city - - - - -	1,000.00	1,000.00

Section II

The City Clerk of the City of Nokomis is hereby authorized and directed to promptly file a proper certified copy of this tax levy ordinance with the County Clerk of Montgomery County, Illinois, and the said County Clerk is hereby directed and requested to ascertain the rate per cent which upon the total valuation of all property subject to taxation within the said City, as that property is assessed and equalized for State and County purposes, will produce a net amount payable to the City of Nokomis, of not less than the amount so levied, and to extend such tax on the book or books of the collector of taxes and cause such tax to be collected in the manner required by statute.

Section III

This ordinance shall be in full force and effect, from and after its passage and approval as provided by law.
