ORDINANCE NO. 441

ANNUAL TAX LEVY ORDINANCE FOR THE FISCAL YEAR ENDING ON THE 30TH DAY OF APRIL, A. D. 1954.

WHEREAS, the City Council of the City of Nokomis did, on June 1st
pass the annual appropriation ordinance for said City of the fiscal year ending on the 30th
dya of April A. D. 1954, in the aggregate sum of One Hundred Forty-three Thousand, Four
Hundred Twelve Dollars and Forty-nine Cents (\$143,412.49), which said ordinance was duly
published in the Free Press-Progress, the official newspaper of said city, on
