ORDINANCE NO. 461

ANNUAL TAX LEVY ORDINANCE FOR THE FISCAL YEAR ENDING on THE 30 DAY OF APRIL, A.D. 1959.

WHEREAS, the City Council of the City of Nokomis, did on the 16th day of June, 1958, pass the annual appropriation ordinance for said City for the fiscal year ending on the 30th day of April, A.D. 1959, in the aggregate sum of One Hundred Twenty-Eight Thousand One Hundred Sixty Three Dollars and Thirty Cents (\$128,163.30), which said ordinance was duly published in the Free Press Progress, the official newspaper of said Chy on June 19, 1958, and is now in full force and effect and on file with the City Clerk, and

WHEREAS, the City Council having ascertained the total amount of appropriations legally made for all corporate purposes to be provided for by the tax levy of the current fiscal year:

Now, therefore, be it ordained by the City Council of the City of Nokomis, Illinois:

That there be and there is hereby levied upon all property subject to taxation, both real and personal, within the corporate limits of the City of Nokomis, Illinois as the same is assessed and equalized for State and County purposes, for the fiscal year ending on the 30th day of April, A.D. 1959, the total sum of Sixty-Six Thousand Two Hundred Thirteen Dollars and Thirty Cents (\$66,213.30) and the following specific purposes mentioned in said appropriation ordinance and in the respective sums as follows, the total amount of appropriations being detailed under the column headed "Amount Appropriated", and the total amount levied being detailed under the column headed "Amount Levied", as follows, to-wit:
