ORDINANCE NO 500

AN ORDINANCE DECLARING A NUISANCE  
AND REGULATING THE MAINTENANCE OF  
LIVESTOCK WITHIN THE CITY LIMITS  
OF THE CITY OF NOKOMIS, MONTGOMERY  
COUNTY, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Montgomery County, Illinois:

SECTION I. That it is hereby declared to be a nuisance for any person, firm or corporation to house, keep, maintain or pasture any swine, cattle, sheep, goats or horses within a distance of five hundred (500) feet from any building or structure occupied by any person or persons whether as a business or residence in the City of Nokomis, Montgomery County, Illinois.

SECTION II. That it shall be unlawful for any person, firm or corporation to house, keep, maintain or pasture any swine, cattle, sheep, goats or horses within a distance of five hundred (500) feet from any building or structure occupied by any person or persons whether as a business or residence in the City of Nokomis, Montgomery County, Illinois.

SECTION III. Any person, firm or corporation who shall house, keep, maintain or pasture any swine, cattle, sheep, goats or horses within a distance of five hundred (500) feet from any building or structure occupied by any person or persons whether as a business or residence in the City of Nokomis, Montgomery County, Illinois, in violation of this ordinance shall for each offense be fined in the sum of not less than Twenty Five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00) for each offense.

SECTION IV. Any Ordinance or Ordinances of the said City of Nokomis now in full force and effect and in conflict with this Ordinance is hereby expressly repealed.

This Ordinance shall be in effect immediately after its passage and publication according to law.
