

ORDINANCE NO. 502

AN ORDINANCE REGULATING PARKING ON SOUTH STREET, SOUTH PINE STREET, WEST SPRUCE STREET AND SOUTH VINE STREET IN THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Montgomery County Illinois:

SECTION I. That it shall be unlawful for any person, firm or corporation to park any motor vehicle, bicycle or horse drawn vehicle on the north side of that portion of South Street in said City of Nokomis, Illinois extending between South Pine Street and South Spruce Street in said city; on the East side of that portion of South Pine Street in said City of Nokomis, Illinois extending between West Union Street and West South Street in said City; on the West side of that portion of South Spruce Street in said City of Nokomis, Illinois extending between East Union Street and Sandford Avenue in said City; on the East side of South Vine Street in said City of Nokomis, Illinois extending between West Union Street and West South Street in said City.

SECTION II. Any person, firm or corporation who shall park any motor vehicle, bicycle or horse drawn vehicle on the north side of that portion of South Street in said City of Nokomis, Illinois extending between South Pine Street and South Spruce Street in said City; on the East side of that portion of South Pine Street in said City of Nokomis Illinois extending between West Union Street and West South Street in said City; on the West side of that portion of South Spruce Street in said City of Nokomis, Illinois extending between East Union Street and Sandford Avenue in said City; on the East side of South Vine Street in said City of Nokomis, Illinois extending between West Union Street and West South Street in said City in violation of this ordinance shall for each offense be fined in the sum of not less than Five Dollars (\$5.00) nor more than Twenty five Dollars (\$25.00) for each offense.

SECTION III. Any Ordinance or Ordinances of the said City of Nokomis now in full force and effect and in conflict with this Ordinance of the said City of Nokomis now is hereby expressly repealed.
