## ORDINANCE NO. 511

ORDINANCE ABOLISHING THE OFFICE OF POLICE MAGISTRATE IN THE CITY OF NOROMIS, MONTGOMERY COUNTY, ILLINOIS

WHEREAS, SECTION 12 of Article VI of the Constitution of the State
of Illinois, as amended the 6th of November, 1962, provides as follows;

"Subject to law, the circuit judges in each circuit shall
appoint magistrates to serve at their pleasure; provided
that in Cook County, until and unless changed by law, at
least one-fourth of the magistrates shall be appointed
from and reside in the area outside the corporate limits
of the City of Chicago."

AND

WHEREAS, the foregoing provision shall go into effect in Illinois the 1st of January, 1964, and will apply to the appointment of magistrates having jurisdiction in the City of Nokomis, Illinois, and

WHEREAS, the term of office of the present Police Magistrate expires on the 50th day of April, 1963, and the office of the same is now vacant, and

WHEREAS, if a successor is elected to succeed the present police magistrate, his term of office will be for four years, beginning the 1st of May, 1965, his term contining for over three years beyond the time that Section 12 of Article VI of the Constitution of Illinois goes into effect, and

WHEREAS, the Supreme Court of Illinois has held in People ex rel. Wellman vs. Washburn, 410 Ill. 322, 102 N. E. 2nd 124, that

"Election of a Police Magistrate was not mandatory and was within discretion of City Council."

NON

THEREFORE BE IT ORDARINED BY THE COUNCIL OF THE CITY OF NORONIS,
MONTGOMERY COUNTY, ILLINOIS; THAT

Section L. The office of police magistrate be abolished and it is hereby abolished in the City of Nokomis, Illinois, effective May 1, 1965.

Section 2. The City Clerk of Nokomis, Illinois, be hereby directed to accept no petitions of candidates for the election to the office of Police Magistrate for the City of Nokomis, Illinois, and to provide for no such office on any ballot used in the next municipal election of City officers.

Section 3. The City Clerk of Nokomis, Illinois, be and she is hereby directed to publish this ordinance at the earliest opportunity following its passage by the Council, approval by the Mayor, and attestation the the City Clerk.
