ORDINANCE NO. 527

AN ORDINANCE REGULATING HOUSE TO HOUSE SELLING,  
SOLICITING OR DISTRIBUTION OF GOODS, WARES AND  
MERCHANDISE IN THE CITY OF NOKOMIS, MONTGOMERY  
COUNTY, ILLINOIS

BE IT ORDAINED by the City Council of the City of Nokomis, Montgomery County,  
Illinois,

SECTION I. That it shall be unlawful for any person, firm or corporation  
ration to, at any time hereafter, sell, solicit or distribute any goods, wares or  
merchandise, including newspapers and magazines, from house to house or from door to  
door in the City of Nokomis, Illinois, unless said person, firm or corporation shall  
at least five (5) days prior to the selling, soliciting or distributing of said above  
named items submit written information to the City Clerk of the City of Nokomis,  
Illinois stating the dates said sale, solicitation or distribution of the above named  
items shall be made, setting out the specific sections of said city where said sale,  
solicitation or distribution of said items shall be made and the name and address  
of the principal person, firm or corporation making said sale, solicitation or  
distribution and the name and address of the salesman, if any, who shall make such  
sale, solicitation or distribution of said items.

SECTION II. Any person, firm or corporation violating any provisions of  
this Ordinance shall be fined not less than Twenty Five Dollars (\$25.00) nor more than  
One Hundred Dollars (\$100.00) for each offense.

SECTION III. Any Ordinances in conflict with this Ordinance is hereby  
expressly repealed.
