

ORDINANCE NO. 533

AN ORDINANCE DIRECTING THE SALE OF REAL ESTATE  
OWNED BY THE CITY OF NOKOMIS, ILLINOIS

Be it ordained by the City Council of the City of Nokomis, Montgomery County,  
Illinois:

SECTION I. That it is the opinion of the Mayor and the City Council of the  
City of Nokomis, Illinois that the following described real estate is no longer necessary  
appropriate or required for the use of or profitable to said City of Nokomis:

Tract I

Beginning at the Northeast corner of Block H in Kettelkamp's Addition  
to the City of Nokomis, Illinois, running thence in a northerly direction  
along the East line of Block G in Kettelkamp's Addition to said City a  
distance of eleven (11) feet; running thence West parallel with the North  
line of said Block H a distance of one hundred twenty two and five tenths  
(122.5) feet; running thence South a distance of eleven (11) feet to the  
Northwest corner of said Block H; running thence East along the North  
boundary line of said Block H a distance of one hundred twenty two and five  
tenths (122.5) feet to the place of beginning, situated in Kettelkamp's  
Addition to the City of Nokomis, County of Montgomery and State of Illinois.

Tract II

Beginning at the Northeast corner of Block K in Kettelkamp's Addition to  
the City of Nokomis, Illinois, running thence in a northerly direction  
parallel with the West line of Block G of Kettelkamp's Addition to said  
City of Nokomis a distance of eleven (11) feet; running thence West  
parallel with the North line of said Block K a distance of one hundred  
twenty five and five tenths (125.5) feet to the West line of Block G in  
Kettelkamp's Addition to the City of Nokomis; running thence South along  
the West line of said Block G a distance of eleven (11) feet to the North-  
west corner of said Block K; running thence East along the North line  
of said Block K a distance of one hundred twenty five and five tenths  
(125.5) feet to the place of beginning, situated in Kettelkamp's Addition  
to the City of Nokomis, County of Montgomery and State of Illinois.

SECTION II. That the above described real estate be sold at public sale.

SECTION III. That the City Clerk of said City of Nokomis, Illinois, publish  
the following notice in the Free Press Progress, a newspaper published in the City of  
Nokomis, Illinois, said notice being published on July 9, 1964, July 16, 1964 and  
July 23, 1964:

PUBLIC NOTICE IS HEREBY GIVEN that the City of Nokomis, Illinois has on  
the 6th day of July, A.D. 1964 passed Ordinance # 533 directing the public  
sale of real estate not now being used for corporate purposes and described  
as follows:

Tract I.

Beginning at the Northeast corner of Block H in Kettelkamp's Addition  
to the City of Nokomis, Illinois, running thence in a northerly direction

along the East line of Block G in Kettelkamp's Addition to said City a distance of eleven (11) feet; running thence West parallel with the North line of said Block H a distance of one hundred twenty two and five tenths (122.5) feet; running thence South a distance of eleven (11) feet to the Northwest corner of said Block H; running thence East along the North boundary line of said Block H a distance of one hundred twenty two and five tenths (122.5) feet to the place of beginning, situated in Kettelkamp's Addition to the City of Nokomis, County of Montgomery and State of Illinois.

Tract II

Beginning at the Northeast corner of Block K in Kettelkamp's Addition to the City of Nokomis, Illinois, running thence in a northerly direction parallel with the West line of Block G of Kettelkamp's Addition to said City of Nokomis a distance of Eleven (11) feet; running thence West parallel with the North line of said Block K a distance of one hundred twenty five and five tenths (125.5) feet to the West line of Block G in Kettelkamp's Addition to the City of Nokomis; running thence South along the West line of said Block G a distance of eleven (11) feet to the Northwest corner of said Block K; running thence East along the North line of said Block K a distance of one hundred twenty five and five tenths (125.5) feet to the place of beginning, situated in Kettelkamp's Addition to the City of Nokomis, County of Montgomery and State of Illinois.

FURTHER NOTICE IS GIVEN that all persons interested in submitting bids on said above described real estate shall deposit with the City Clerk of Nokomis, Illinois a sealed bid for said described real estate, and that the City Council will at the hour of 7:30 o'clock P.M. on August 17, 1964 at a regular meeting of the City Council of the City of Nokomis, Illinois held at the City Hall in Nokomis, Illinois open and consider said bids and a bid shall be accepted upon a vote of three-fourths (3/4ths) of all members of the City Council.

By a majority vote of the City Council any and all bids may be rejected.
