AN ORDINANCE REGULATING TRAFFIC
ON CERTAIN CITY STREETS WITHIN
THE CITY LIMITS OF THE CITY OF
NOKOMIS, MONTGOMERY COUNTY,
ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS,
THAT:

SECTION 1

Whenever and wherever the word "vehicle" is used in this ordinance, it shall mean all types of motor propelled vehicles including motorcycles and motor-bicycles, and, also said work "vehicle" shall include bicycles and horse drawn vehicles of every kind and nature.

SECTION 11

- A. That the operator of any vehicle proceeding in either direction on South Elm Street in said City of Nokomis shall have the right of way over any operated vehicle entering said South Elm Street from East Central Street in said City of Nokomis,
- B. That the operator of any vehicle proceeding in either direction on South Elm Street in said City of Nokomis shall have the right of way over any operated vehicle entering South Elm Street from East Union Street in said City of Nokomis.
- C. That the operator of any vehicle proceeding in either direction on South Spruce Street in said City of Nokomis shall have the right of way over any operated vehicle entering South Spruce Street from South Street in said City of Nokomis.
- D. That the operator of any vehicle proceeding in either direction on South Union Street in said City of Nokomis shall have the right of way over any operated vehicle entering South Union Street from West South Street in said City of Nokomis.
- E. That the operator of any vehicle proceeding East on East Central Street in said City of Nokomis shall have the right of way over any operated vehicle entering East Central Street from Maple Street in said City of Nokomis.
- F. That the operator of any vehicle proceeding in either direction on South Cedar Street in said City of Nokomis shall have the right of way over any operated vehicle entering South Cedar Street from West Central Street in said City of Nokomis.
- G. That the operator of any vehicle proceeding in either direction on West Union Street in said City of Nokomis shall have the right of way over any operated vehicle entering West Union Street from South Pine Street in said City of Nokomis.

H. That the operator of any vehicle proceeding in either direction on West Union Street in said City of Nokomis shall have the right of way over any operated vehicle entering West Union Street from South Cedar Street in said City of Nokomis

I. That the operator of any vehicle proceeding in either direction on East Union Street in said City of Nokomis shall have the right of way over any operated vehicle entering East Union Street from South Maple Street in said City of Nokomis,

J. That the operator of any vehicle proceeding in either direction on North Pine Street in said City of Nokomis shall have the right of way over any operated vehicle entering North Pine Street from West Front Street in said City of Nokomis.

K. That the operator of any vehicle proceeding in either direction on North Cedar Street in said City of Nokomis shall have the right of way over any operated vehicle entering North Cedar Street from West Front Street in said City of Nokomis.

L. That the operator of any vehicle proceeding in either direction on North Maple Street in said City of Nokomis shall have the right of way over any operated vehicle entering North Maple Street from Warren Street in said City of Nokomis.

SECTION III

A. That the operator of any vehicle proceeding in an Easterly direction on East Union Street in said City of Nokomis shall completely stop said vehicle before entering upon South Elm Street in said City of Nokomis.

B. That the operator of any vehicle proceeding North on Elm Street in said City of Nokomis shall completely stop said vehicle before entering upon East Union Street in said City of Nokomis.

C. That the operator of any vehicle proceeding in an Easterly direction on East Union Street in said City of Nokomis shall completely stop said vehicle before entering upon Capps Avenue in said City of Nokomis.

D. That the operator of any vehicle proceeding in a Westerly direction on East Union Street in said City of Nokomis shall completely stop said vehicle before entering upon Blue Avenue in said City of Nokomis.

E. That the operator of any vehicle proceeding in either direction on Hamilton Street or North Pine Street in said City of Nokomis shall completely stop said vehicle before entering the intersection of Hamilton Street and North Pine Street in said City of Nokomis.

F. That the operator of any vehicle proceeding in either direction on North Cedar Street in said City of Nokomis shall completely stop said vehicle before entering upon Hamilton Street in said City of Nokomis.

G. That the operator of any vehicle proceeding in either direction on North Spruce Street in said City of Nokomis shall completely stop said vehicle before entering upon Hamilton Street in said City of Nokomis.

H. That the operator of any vehicle proceeding in either direction on East Union Street or South Spruce Street in said City of Nokomis shall completely stop said vehicle before entering the intersection of East Union Street and South Spruce Street in said City of Nokomis.

I. That the operator of any vehicle proceeding in an Easterly direction on East Union Street in said City of Nokomis shall completely stop said vehicle before entering upon South Elm Street in said City of Nokomis.

J. That the operator of any vehicle proceeding in either direction on East Central Street in said City of Nokomis shall completely stop said vehicle before entering upon South Elm Street in said City of Nokomis.

K. That the operator of any vehicle proceeding in either direction on South Oak Street in said City of Nokomis shall completely stop said vehicle before entering upon East South Street in said City of Nokomis.

L. That the operator of any vehicle proceeding in either direction on Central Street in said City of Nokomis shall completely stop said vehicle before entering Spruce Street in said City of Nokomis.

M. That the operator of any vehicle proceeding in either direction on Central Street in said City of Nokomis shall completely stop said vehicle before entering Pine Street in said City of Nokomis.

N. That the operator of any vehicle entering upon State Street and North Spruce Street in said City of Nokomis from any direction shall come to a complete stop before entering upon State Street and North Spruce Street in said City of Nokomis.

SECTION IV

Any person, firm or corporation violating any of the provisions of this ordinance shall be fined not less than Five Dollars (\$5.00) nor more than One Hundred

Dollars (\$100.00) for each offense.

SECTION V

Any ordinance or ordinances of said City of Nokomis now in conflict with this ordinance is hereby expressly repealed.
