ORDINANCE NO. 551

ANNUAL TAX LEVY ORDINANCE OF THE CITY OF NOKOMIS, ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 1966 AND ENDING APRIL 30,1967.

WHEREAS, the City Council of the City of Nokomis, did, on the 20th day of June, 1966, pass the annual tax appropriation ordinance for said City for the fiscal year beginning May 1, 1966 and ending April 30, 1967, in the aggregate sum of One Hundred Twenty Two Thousand Eight Hundred Fifty Dollars (\$122,850.00), which said ordinance was duly published in the Free Press Progress, the official newspaper of said City of Nokomis on the 23rd day of June, 1966, and now in full force and effect and on file with the City Clerk, and,

WHEREAS, the City Council having ascertained the total amount of appropriations legally made for all corporate purposes to be provided for by the tax levy of the current fiscal year,

NOW, THEREFORE, be it ordained by the City Council of the City of Nokomis, Illinois:

SECTION 1.

That there by and there is hereby levied upon all property subject to taxation, both real and personal, within the corporate limits of the City of NOkomis, Illinois, as the same is assessed and equalized for State and County purposes, for the fiscal year beginning May 1, 1966 and ending April 30, 1967, the total sum of One Hundred Twenty Two Thousand Eight Hundred Fifty Dollars (\$122,850.00) and the following specific purposes mentioned in said appropriation ordinance and in the respective sums as follows, the total amount of appropriations being detailed under the column headed "Amount Appropriated" and the total amount levied being detailed under the column headed "Amount Levied", as follows, to wit:

The City Clerk of the City of Nokomis, is hereby authorized and directed to promptly file a proper certified copy of this tax levy ordinance with the County Clerk of Montgomery County, Illinois, and the said County Clerk is hereby directed and requested to ascertain the rate per cent upon total valuation of all property subject to taxation within the said City, as that property is assessed and equalized for State and County purposes, will produce a net amount payable to the City of Nokomis of not less than the amount so levied, and to extend such tax on the book or books for the collector of taxes and cause said tax to be collected in the manner required by statute.

SECTION III

This Ordinance shall be in full force and effect, from and after its passage and approval as provided by law.
