AN ORDINANCE REGULATING  
TRAFFIC ON CERTAIN CITY STREETS  
WITHIN THE CITY LIMITS OF THE CITY  
OF NOKOMIS, MONTGOMERY COUNTY,  
ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS, THAT:

SECTION I

Whenever and wherever the word "vehicle" is used in this ordinance, it shall mean all types of motor propelled vehicles including motorcycles and motor-bicycles, and, also said word "vehicle" shall include bicycles and horse drawn vehicles of every kind and nature.

SECTION II

A. That the operator of any vehicle proceeding in any direction on North Walnut Street in said City of Nokomis shall have the right of way over any operated vehicle entering said North Walnut Street from Franklin Street in said City of Nokomis.

B. That the operator of any vehicle proceeding in any direction on North Pine Street in said City of Nokomis shall have the right of way over any operated vehicle entering said North Pine Street from Franklin Street in said City of Nokomis.

C. That the operator of any vehicle proceeding in any direction on North Pine Street in said City of Nokomis shall have the right of way over any operated vehicle entering said North Pine Street from Warren Street in said City of Nokomis.

D. That the operator of any vehicle proceeding in any direction on North Cedar Street in said city of Nokomis shall have the right of way over any operated vehicle entering said North Cedar Street from Warren Street in said City of Nokomis.

E. That the operator of any vehicle proceeding in any direction on South Maple Street in said city of Nokomis shall have the right of way over any operated vehicle entering said South Maple Street from South Street in said city of Nokomis.

F. That the operator of any vehicle proceeding in any direction on South Pine Street in said City of Nokomis shall have the right of way over any operated vehicle entering said South Pine Street from South Street in said City of Nokomis.

G. That the operator of any vehicle proceeding in any direction on South Spruce Street in said city of Nokomis shall have the right of way over any operated vehicle entering South Spruce Street from Sandford Avenue in said City of Nokomis.

H. That the operator of any vehicle proceeding in any direction on Union Street in said City of Nokomis shall have the right of way over any operated vehicle entering Union Street from South Street in said City of Nokomis.

SECTION III

Any person, firm or corporation violating any of the provisions of this ordinance shall be fined not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00) for each offense.

SECTION IV

Any ordinance or ordinances of said City of Nokomis now in conflict with this ordinance is hereby expressly repealed.
