ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF NOKOMIS ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 1968 and ENDING APRIL 30, 1969.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS:
