ORDINANCE NO. 589

ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF NOKOMIS, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 1969 and ENDING APRIL 30, 1970.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS:

SECTION I. That the following sums be and the same are hereby appropriated out of the revenue of the City of Nokomis, Montgomery County, Illinois, for the fiscal year ending on the 30th day of April, A.D. 1970, and the specific objects and purposes for which said sums are appropriated in detail are as follows:
