ORDINANCE NO. 606

ANNUAL TAX LEVY ORDINANCE OF THE CITY OF NOKOMIS, ILLINOIS, FOR THE FISCAL YEAR BEGINNING ON MAY 1, 1970, and ENDING ON APRIL 30, 1971.

WHEREAS, the City Council of the City of Nokomis, did, on the 15th day of June, A.D. 1970, pass the annual tax appropriation ordinance for said City of Nokomis for the fiscal year beginning on May 1, 1970 and ending April 30, 1971, in the aggregate sum of Two Hundred Twenty One Thousand Five Hundred Twelve and 48/100 Dollars (\$221,512.48) which said Ordinance was duly published in the Free Press Progress, the official newspaper of said City of Nokomis, on the 18th day of June, A.D. 1970, and is now in full force and effect and on file with the City Clerk, and,

WHEREAS, the City Council having ascertained the total amount of appropriations legally made for all corporate purposes to be provided for by the tax levy of the current fiscal year,

NOW THEREFORE, be it ordained by the City Council of the City of Nokomis,

## SECTION I

That there be and there is hereby levied upon all property subject to taxation, both real and personal, within the corporate limits of the City of Nokomis, Illinois, as the same is assessed and equalized for State and County purposes, for the fiscal year beginning May 1, 1970 and ending April 30, 1971, the total sum of Two Hundred Twenty One Thousand Five Hundred Twelve and 48/100 Dollars (\$221,512.48), and the following specific purposes mentioned in said appropriation ordinance and in the respective sums as follows, the total amount of appropriations being detailed under the column headed "Amount Appropriated" and the total amount levied being detailed under the column headed "Amount Levied", as follows, to wit:
