

ORDINANCE NO. 609

AN ORDINANCE REGULATING THE PARKING OF VEHICLES
ON SOUTH MAPLE STREET AND STEVENS STREET IN THE
CITY OF NOKOMIS, ILLINOIS.

BE IT ORDAINED by the City Council of the City of Nokomis, Montgomery County, Illinois, that:

SECTION I. It shall be unlawful for any person, firm or corporation to park any motor vehicle, horse drawn vehicle, or manually operated vehicle on either side of that portion of South Maple Street extending from Capps Avenue to Stevens Street in the said City of Nokomis, and on either side of that portion of Stevens Street extending from East Union Street to Water Street, all in said City of Nokomis, County of Montgomery and State of Illinois.

SECTION II. Any person, firm or corporation violating any of the provisions of this Ordinance shall be fined not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00) for each offense.

SECTION III. Any ordinance or ordinances of said City of Nokomis now in conflict with this Ordinance is hereby expressly repealed.

SECTION IV. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
