

ORDINANCE NO. 618

AN ORDINANCE REGULATING TRAFFIC AT THE INTERSECTIONS OF NORTH MAPLE STREET AND EAST FRONT STREET; SOUTH CEDAR STREET AND WEST SOUTH STREET; BLUE AVENUE AND YOUNG STREET; WATER STREET AND CAPPS AVENUE; WATER STREET and SINGER AVENUE; SCHOOL STREET AND SINGER AVENUE; and NORTH WALNUT STREET AND ~~NORTH~~ ^{West} HAMILTON STREET.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS, THAT:

SECTION I. Traffic on ~~North Maple~~ ^{East Front} Street shall yield the right of way to traffic on ~~East Front~~ ^{North Maple} Street; traffic on South Cedar Street shall yield right of way to traffic on West South Street; traffic on Blue Avenue shall yield right of way to traffic on Young Street; traffic on Water Street shall yield the right of way to traffic on Capps Avenue; traffic on Water Street shall yield the right of way to traffic on Singer Avenue; traffic on School Street shall yield the right of way to all traffic on Singer Avenue; and all traffic proceeding North on North Walnut Street in said City of Nokomis shall stop before entering West Hamilton Street in said City.

SECTION II. That it shall be unlawful for any person, firm or corporation operating any vehicle on the above said streets as set out in Section I of this Ordinance to fail to yield the right of way or stop, as enumerated in Section I of this Ordinance.

SECTION III. Any person, firm or corporation violating any of the provisions of this Ordinance shall be fined not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00) for each offense.

SECTION IV. Any ordinance or ordinances of said City of Nokomis now in conflict with this Ordinance is hereby expressly repealed.

SECTION V. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
