ORDINANCE NO. 634

AN ORDINANCE REQUIRING A PERMIT FOR TRAILER COACHES LOCATED IN THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS:

SECTION !

Definition: As used in this ordinance, the following term shall have the meaning indicated below:

"Trailer Coach" shall mean and include any vehicle or similar portable

'Trailer Coach' shall mean and include any vehicle or similar portable structure constructed so as to permit its being used as a conveyance on a public street and so as to permit the occupancy thereof as a dwelling by one or more persons.

SECTION II

Permit Required: It shall be unlawful to establish, maintain or operate any trailer coach in the municipality of Nokomis, Illinois, without first having obtained a permit therefor. Application for such permit shall be made in writing to the City Clerk of the City of Nokomis, Illinois, stating the following information:

- Each application shall be accompanied by a plan or sketch showing the size and location of the trailer coach to be situated in said municipality.
- 2. Each application so as ubmitted to the City Clerk of said municipality shall be accompanied by a fee of Twenty Five Dollars (\$25.00).

SECTION III

Upon the above application, together with said fee of Twenty Five Dollars (\$25.00) being submitted to the City Clerk of said municipality, the City Clerk shall issue to said applicant a permit for the establishment, maintenance and operation of said trailer coach in said City of Nokomis, Illinois.

SECTION IV

Any person violating any of the provisions of this ordinance shall be fined not less than Twenty Five Dollars (\$25.00), nor more than One Hundred Dollars (\$100.00) for each offense.

SECTION V

Any ordinance or ordinances of said City of Nokomis now in conflict with this ordinance is hereby expressly repealed.

SECTION VI

This ordinance shall be in full force and effect from and after its
