

ORDINANCE NO. 637

AN ORDINANCE REGULATING PUBLIC ASSEMBLIES, MEETINGS, AND PARADES IN THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS:

Section 1. That no person, firm or corporation shall sponsor or permit, or

cause to be permitted, any parade over the public property of the City of Nokomis, Illinois, or any meetings, or assemblies on the property of the City of Nokomis, Illinois, including the streets and alleys of said City of Nokomis unless said

person, firm or corporation shall within five (5) days prior to said parade, meet- ing or public gathering, obtain a permit for the same from the City Clerk of the City of Nokomis, Illinois, submitting to the Clerk the date and location of said

parade, public meeting or gathering, the sponsor of the same, and the purpose for which said parade, meeting or public gathering is being had. Upon said information being submitted to said City Clerk of the City of Nokomis, the City Clerk shall

then issue to said person, firm or corporation a permit to hold said parade, meeting or public gathering at the time and place in the City of Nokomis, so given to said City Clerk by said sponsor.

Section 11. In the event that said parade, public meeting or gathering is to be had within said City of Nokomis for an illegal purpose, then said City Clerk of said City shall have the authority to refuse to issue a permit for the same.

Section 111. Any person violating any provisions of this Ordinance shall be fined a sum not less than Twenty Five Dollars (\$25.00) nor more than Two Hundred Dollars (\$200.00) for each offense.

Section 11V. Any ordinance or ordinances of said City of Nokomis, now in conflict with this ordinance is hereby expressly repealed.

Section V. This ordinance shall be in full force and effect from and after its passage, approval and publication, according to law.
