

AN ORDINANCE REGULATING THE PLANTING, MAINTENANCE, AND
REMOVAL OF TREES, SHRUBS AND FLOWERS, ON CITY PROPERTY
WITHIN THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY,
THAT:

SECTION 1. No person, firm or corporation shall hereafter plant any tree,

shrub, flowers or other foliage on the boulevards or any city property of the
city of Nokomis, Montgomery County, Illinois; however, any person, firm or
corporation shall be allowed to plant, maintain or remove any trees, shrubs, flowers

or foliage on any city property of the city of Nokomis, Montgomery County, Illinois,
if they shall before said planting, maintenance or removal of the same, obtain
permission from the Commissioner of Public Streets of Nokomis for said operations.

SECTION 11. No person, firm or corporation shall permit any tree, flowers,

shrubs or foliage which may be located upon their property to grow and extend
over any boulevard or city property of said city of Nokomis.

SECTION 111. Upon notification by the Commissioner of Streets of the city

of Nokomis to any person, firm or corporation, that its, his or her trees, shrubs,
flowers or foliage are growing and extending over any boulevard or city property

of the city of Nokomis, and upon further notification to remove said growth over
said city property, then the Commissioner of Streets of the city of Nokomis shall

have the power and authority to remove said growth as aforesaid over the boulevard
and public city property of the city of Nokomis, and may go upon the land or

property of the person, firm or corporation permitting said growth over said
city property for the purpose of removing said growth from the property and

boulevard of the city of Nokomis.

SECTION 111. Any ordinance or ordinances of said city of Nokomis, now in

conflict with this ordinance is hereby expressly repealed.

SECTION 1V. This ordinance shall be in full force and effect from and

after its passage, approval and publication, according to law.
