

ORDINANCE NO. 660

AN ORDINANCE ESTABLISHING AND NAMING BOTTOMLEY STREET  
IN THE CITY OF NOKOMIS, COUNTY OF MONTGOMERY, AND  
STATE OF ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONGTOMERY COUNTY,  
ILLINOIS, THAT:

SECTION I. That the following described tract of land lying within the City  
of Nokomis, will be hereafter known as Bottomley Street in said city. The description  
of said Bottomley Street is as follows, to-wit:

Beginning at the Southwest corner of Lot Nine (9) in Sunrise Subdivision  
of a part of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Fourteen (14), Township  
Ten (10) North, Range Two (2) West of the 3rd P.M., in the City of Nokomis,  
running thence South a distance of fifty (50) feet; running thence North-  
easterly along the North line of Section Twenty Three (23), Township Ten  
(10) North, Range Two (2) West of the 3rd P.M., a distance of 790 feet to the  
West line of East Street in said City of Nokomis; running thence Northwesterly  
along the West line of said East Street a distance of 40 feet to the Southeast  
corner of Lot Seventeen (17) in Sunrise Subdivision of a part of the Southwest  
Quarter (SW $\frac{1}{4}$ ) of Section Fourteen (14), Township Ten (10) North, Range Two (2) <sup>3</sup>  
West of the 3rd P.M., situated in the City of Nokomis, County of Montgomery  
and State of Illinois, thence running Northwesterly a distance of 790 feet to  
said Southwest corner of Lot Nine (9) being the point of beginning.

SECTION II. This ordinance shall be in full force and effect from and after  
its passage, approval and publication according to law.
