ORDINANCE NO. 661

ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF NOKOMIS, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 1975 and ENDING APRIL 30, 1976

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS:

SECTION 1. That the following sums be and the same are hereby appropriated out of the revenue of the City of Nokomis, Montgomery County, Illinois, for the fiscal year ending on the 30th day of April, A.D. 1976, and the specific objects and purposes for which said sums are appropriated in detail are as follows:

13.	For Bonded Indebtedness Fund appropriated as follows:
	(a) Paying the indebtedness of said City and interest thereon as provided by Ordinance No. 437
14.	For an Insurance and Bond Premium Fund appropriated as follows:
	(a) Insurance premiums on City property
15.	For a Public Benefit Fund to be used for the payment of assessments for public benefits against the City \$ 1,000.00
16.	For a Federal Old Age and Survivors' Insurance System Fund for the employees for the City of Nokomis
17.	For a contingent fund to be used for the payment of contingent claims and expenses
18.	For a Civil Defense Fund to be used for the civil defense of said City as provided by Ordinance No. 556 \$ 1,000.00
19.	For a Fire Protection Fund, appropriated as follows:
	(a) To be used for the purpose of fire protection in the City of Nokomis, as authorized by Ordinance No. 594 \$ 3,000.00

- 20. For a Police Protection Fund, appropriated as follows:
 - (a) For the purpose of police protection in the City of Nokomis, as authorized by Ordinance No. 593 \$ 3,000.00
- 21. For a fund for Revenue Sharing between the United States Government and the City of Nokomis, Montgomery County, Illinois, in the amount to be received from the United States Government under the Revenue Sharing Program with said City for twelve (12) months beginning July 1, 1975, and ending June 30, 1976, the sum of TWENTY TWO THOUSAND EIGHT HUNDRED FORTY TWO DOLLARS (\$20,842.00).
