

ORDINANCE NO. 665

AN ORDINANCE REGULATING THE CHARGES FOR THE INSTALLATION OF WATER SERVICE TO CUSTOMERS OF THE CITY OF NOKOMIS, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS, THAT:

SECTION I. That any person, firm or corporation desiring water service from the City of Nokomis, Montgomery County, Illinois, shall deposit with the Clerk of said City the sum of \$175.00. On the receipt of said deposit, the City of Nokomis will extend water service to said customer from the water main to the water meter of said customer at the expense of said City, provided, however, the water meter of said customer shall be located at all times on City of Nokomis property and further, provided, however, that the City of Nokomis shall provide labor, material or service in the installation of said water service to said customer not to exceed the distance of sixty (60) feet from the water main.

SECTION II. In the event that the water meter of the customer is more than sixty (60) feet from the water main of said City of Nokomis, the customer shall be liable for all labor and material for the installation of said water service beyond the distance of sixty (60) feet from the water main. In the event that said water meter of the said customer is located more than sixty (60) feet from the water main of the City of Nokomis, the customer shall use Type K copper pipe in the installation of said water service and shall employ a State of Illinois licensed plumber to completely install said water service, to the water meter of said customer.

SECTION III. Any ordinance or ordinances of said City of Nokomis now in conflict with this Ordinance is hereby expressly repealed.

SECTION IV. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
