ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF NOKOMIS, ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 1976, AND ENDING APRIL 30, 1977

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, ILLINOIS:

SECTION III. That any unexpended balance of any items of any appropriations made by this Ordinance may be expended in making up any insufficiency in any other item of appropriations made by this Ordinance.

SECTION IV. This Ordinance shall be in full force and effect, as provided by law, from and after its final passage, approval and publication.
