

ORDINANCE NO. 671

AN ORDINANCE REGULATING TRAFFIC FROM A NORTHWESTERLY DIRECTION TO A SOUTHEASTERLY DIRECTION PROCEEDING THROUGH THE ALLEY RUNNING IN A NORTHWESTERLY TO A SOUTHEASTERLY DIRECTION THROUGH BLOCK THIRTY-TWO IN THE ORIGINAL TOWN, NOW CITY, OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS:

Section I. That no person, firm or corporation shall operate any motor vehicle, including motorcycles or bicycles, except from a Northwesterly direction to a Southeasterly direction through the alley running in a Northwesterly to a Southeasterly direction through Block Thirty-two (32) in the original Town, now City, of Nokomis, Montgomery County, Illinois, also known as the alley adjacent to the vacant lot located on State Street in Nokomis, Montgomery County, Illinois.

Section II. The City of Nokomis shall erect an appropriate sign designating the route of traffic, in conformity with this Ordinance.

Section III. Any person, firm or corporation violating any of the provisions of this Ordinance shall be fined not less than Twenty-five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00) for each offense.

Section IV. Any ordinance or ordinances of said City of Nokomis now in conflict with this Ordinance is hereby expressly repealed.

Section V. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
