# ORDINANCE NO. 678

ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF NOKOMIS, ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 1977, AND ENDING APRIL 30, 1978

BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF NOKOMIS, MONTGOMERY, COUNTY, ILLINOIS, THAT:

# X. REVENUE SHARING

(14) For an anti-recession fund for revenue sharing between the United States Government and the City of Nokomis, Montgomery County, Illinois, in the amount to be received from the United States Government under the Revenue Sharing Program with said City for six (6) months beginning

January 1, 1977, and ending September 30, 1977, the sum of SIX THOUSAND DOLLARS (\$6,000.00).

Section II. That the sums of money appropriated by the provisions of this Ordinance total FOUR HUNDRED NINETY SIX THOUSAND THREE HUNDRED FIFTY ONE and 72/100 Dollars (\$496,351.72).

Section III. That any unexpended balance of any items of any appropriations made by this Ordinance may be expended in making up any insufficiency in any other item of appropriations made by this Ordinance.

Section IV. This Ordinance shall be in full force and effect, as provided by law, from and after its final passage, approval and publication.
