ORDINANCE NO. 692

AN ORDINANCE REPEALING ORDINANCE NO. 682 VACATING AN ALLEY TWENTY FEET IN WIDTH BETWEEN LOTS ONE, TWO AND THREE, AND LOTS FOURTEEN, FIFTEEN, AND SIXTEEN, ALL IN BLOCK FOUR IN MILLER & YOUNG'S ADDITION TO THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS, THAT:

SECTION 1. That Ordinance No. 682, being an ordinance vacating an alley twenty feet in width between Lots One, Two and Three, and Lots Fourteen, Fifteen, and Sixteen, all in Block Four in Miller & Young's Addition to the City of Nokomis, Montgomery County, Illinois, passed by the City Council of the City of Nokomis, Illinois, at a regular meeting thereof on August 8, 1977, be hereby repealed.

SECTION 2. This ordinance shall become effective immediately upon its passage.
