ORDINANCE NO. 693

AN ORDINANCE VACATING PART OF A PUBLIC ALLEY  
IN BLOCK FOUR IN MILLER & YOUNG'S SECOND ADDITION  
TO THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS,  
THAT:

SECTION 1. That the alley hereinafter described is no longer required for  
public use and the public interests will be subserved by vacating said alley.

SECTION 2. That part of a heretofore dedicated alley, legally described as  
follows:

The northerly one hundred fifty (150) feet of the twenty (20) foot public  
alley in Block Four (4) in Miller and Young's Second Addition to the City  
of Nokomis, situated in the City of Nokomis, Montgomery County, Illinois,

BE AND THE SAME HEREBY IS VACATED AND CLOSED.

SECTION 3. A certified copy of this ordinance shall be filed by the City Clerk  
of the City of Nokomis, Illinois, for record in the office of the Recorder of Deeds  
in Montgomery County, Illinois, within thirty (30) days after the passage of this  
ordinance.

SECTION 4. This ordinance shall be in full force and effect from and after its  
passage and approval, as required by law.

22 day of March, 1978, and deposited and filed in the office of the City Clerk  
in said City on that date.
