

ORDINANCE NO. 701

AN ORDINANCE ANNEXING HARGRAVE'S ADDITION TO THE TOWNSHIP OF NOKOMIS EXCEPT THAT PART THEREOF PRESENTLY CONTAINED WITHIN THE CORPORATE LIMITS OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS.

WHEREAS, a written petition, signed and verified by the legal owners of record of all the land within the territory hereinafter described, has been filed with the City Clerk of the City of Nokomis, Montgomery County, Illinois, requesting that said territory be annexed to the City of Nokomis; and,

WHEREAS, there are no electors residing within said territory; and,

WHEREAS, said territory is not within the corporate limits of any municipality but is contiguous to the City of Nokomis; and,

WHEREAS, said territory is not a part of a Fire Protection District or a Public Library District:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS:

Section 1. That the following described territory:

Hargrave's Addition to the Township of Nokomis as shown by the Plat thereof filed in the office of the Recorder of Montgomery County, Illinois, on November 15, 1978, as Document Number 263599 in Plat Records, Slide 51, excepting the portion thereof presently contained within the corporate limits of the City of Nokomis;

being indicated on an accurate map of the annexed territory (which is appended to and made a part of this Ordinance) is hereby annexed to the City of Nokomis, Montgomery County, Illinois.

Section 2. That the City Clerk is hereby directed to record with the Recorder of Deeds and to file with the County Clerk a certified copy of this Ordinance, together with the accurate map of the territory annexed appended to said ordinance.

Section 3. That this Ordinance shall be in full force and effect from and after its passage and approval.

and in support thereof, states as follows:



1. There are no electors residing within the territory to be annexed.


