

ORDINANCE NO. 782

AN ORDINANCE REGULATING THE FLOW OF MOTOR VEHICLE TRAFFIC IN THE CITY OF NOKOMIS BY ESTABLISHING, DISESTABLISHING OR AMENDING THE LOCATION OF TRAFFIC-CONTROL SIGNS IN THE SAID CITY

WHEREAS the mayor and the commissioners of the City of Nokomis have considered traffic-control questions urged upon the City Council of the said City since the inauguration of the said body and have, following a detailed consideration of such questions, concluded that the public health and safety of motorists and pedestrians in the said City require revisions to the locations of traffic-control signs within the said City pursuant the §24-3-5 of the "Revised Code of Ordinances of the City of Nokomis, Montgomery County, Illinois",

BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF NOKOMIS:

Section 1: That the below-described stopsigns are hereby authorized, and shall forthwith be erected, at those locations hereinafter set forth for them:

<u>Through Street</u>	<u>Stop Street (Direction)</u>
South Union Street	South Street (West Bd.)
Oberle Street	Madison Street (East Bd.)
Kinney Street	Morgan Street (Southeast Bd.)
Kinney Street	Lena Street (North Bd.)
Kinney Street	Edwards Street (North Bd.)

Section 2: That the below-described intersection is hereby designated a "three-way stop" intersection, and stopsigns shall forthwith be erected to all streets intersecting there:

West Union Street (Southwest Bd.)	at	Kinney Street (East Bd.) and South Union Street (North Bd.)
--------------------------------------	----	-------------------------------------------------------------------

Section 3: That the below-described intersections are hereby designated "four-way stop" intersections, and stopsigns shall forthwith be

erected for all streets intersecting there:

South Maple Street	at	Capps Avenue
Young Street	at	Blue Avenue
Webster Street	at	Singer Avenue

Section 4: That the following intersections are designated as yield right-of-way streets:

<u>Through Street</u>	<u>Yield Street (Direction)</u>
East Front Street	Bottomley Street (East Bd.)
East Front Street	East Street (South Bd.)

Section 5: That the replacement of "yield" signs by stopsigns wherever stopsigns are mandated herein is expressly directed.

Section 6: (Partial Invalidity): That if any section, subdivision, sentence or clause of this ordinance is for any reason held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

Section 7: That this ordinance shall be in full force and effect from and after its passage, approval and publication, according to law.
