REVISED CODE OF ORDINANCES


BE IT ORDAINED BY MAYOR AND CITY COUNCIL OF THE CITY OF NOKOMIS AS FOLLOWS:

Section 24-3-4 of the City of Nokomis Revised Code of Ordinances is hereby amended by adding the following to Schedule K:


<u>THROUGH STREET</u>	<u>YIELD STREET (DIRECTION)</u>
