# AN ORDINANCE AMENDING CHAPTER 30, PUBLIC SAFETY OF THE REVISED CODE OF ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS TO ESTABLISH STANDARDS FOR PART-TIME POLICE OFFICERS

WHEREAS, Illinois Law requires that Municipalities hiring part-time police officers must establish hiring standards for such part-time police officers;

NOW, THEREFORE, be it ordained by the City Council of the City of Nokomis, Illinois, that Chapter 30, Public Safety of the Revised Code of Ordinances shall be amended to 30-2-52 as follows:

30-2-52 THE HIRING STANDARDS FOR PART-TIME POLICE OFFICERS: The City of Nokomis may hire from time to time part-time police officers. When part-time police officers are hired they must meet the standards as set forth below. This is in addition to other requirements that the City may consider to be relevant for police officers from time to time.

A. All persons requesting to be considered for hiring as part-time police officers candidates shall:

- Submit a formal written and signed application for employment.
- Pass a complete background check, character, criminal and work history.

B. After completion of step 1, the application and background check will be submitted to the Nokomis City Council for approval to proceed with the process.

C. All candidates must register with the City Clerk of Nokomis, submit pre-certification finger prints and pass an approved physical examination following receiving approval of the council.

D. All approved candidates shall complete or have been precertified in the following:

- 1. Shall pass the approved physical power test for the State of Illinois.
- All candidates shall either have an approved waiver of training from the Illinois Law Enforcement Training and Standards Board or be enrolled and attending an approved part-time training course required by the Illinois Law Enforcement Training and Standards Board.
- 3. Shall pass the required 40 hour mandatory firearms

E. All part-time officers shall complete the above requirements and other mandatory training required by the department or be discharged from service pending approval of termination by the City Council of Nokomis.

F. The maximum hours for an approved part-time officer shall be 1560 hours per calendar year, as provided by State Statute.

This Ordinance shall be in full force and effect from and after passage and approval as provided by law.
